If you are studying for a NEBOSH qualification, we would like to remind you that guidance from NEBOSH is available in the following publications, which can all be accessed from the 'Qualifications' area of the NEBOSH website (under 'Resources' for each relevant qualification):

#### Note

NEBOSH use the following terms in relation to their assessments - we thought it would be useful to clarify what RRC see these as, so we can put your mind at ease, as it could be a little confusing:

- **Digital assessment**: the way the assessment is delivered and completed is entirely electronic, meaning you download the assessment paper and submit it electronically using the NEBOSH platform.
- **Scenario-based assessment**: this is the style of the assessment. It uses a scenario which you need to read, refer to and rely on when answering the questions/completing the tasks in the paper.
- **Open-book exam**: this is the format of the assessment. An open-book exam, as you know, allows you to refer to resources and notes while you are completing the paper.

# RRC Health and Safety Law and Case Law Guide NOTE

The Sentencing Act 2020 (Magistrates' Court Sentencing Powers) (Amendment) Regulations 2024 have increased the maximum sentence that may be imposed by a Magistrates' Court for a single triable-either-way offence (a criminal offence that can be heard in either a Magistrates' Court or a Crown Court) from six months to 12 months. These Regulations came into force on 18 November 2024 and apply to England and Wales. They are relevant to the entries on the Health and Safety (Offences) Act 2008 and the Modern Slavery Act 2015, which will be updated shortly.

#### RRC Environmental Law and Case Law Guide

We have updated the Environmental Law and Case Law Guide in relation to some recent legislation. If you are studying a national (UK) course, please note the changes below.

#### **Environmental Permitting (England and Wales) Regulations 2016**

In this entry, at the end of the section headed **Introduction**, the following new paragraph has been added:

"The **Environmental Permitting (England and Wales) (Amendment) Regulations 2023** amend Schedule 9 of the Regulations to require operators of material facilities permitted sites to notify the relevant regulator (the Environment Agency or Natural Resources Wales) if they receive 1,000 tonnes or more of any waste material. Material facilities are sites that sort mixed waste into specific waste streams which are then sent or transferred to be recycled."

#### EU Regulation No. 2017/852 on Mercury

At the end of this entry, the following new paragraph has been added:

"An amendment regulation (EU Regulation 2024/1849) amends EU Regulation 2017/852 as follows:

- The use and export of dental amalgam is prohibited by January 2025 (although member states will be allowed to continue the use, manufacture, and import of dental amalgam until 30 June 2026 if more time is needed for national healthcare system adaptations).
- The manufacture, import and export of certain types of mercury-containing lamps will be banned over a period from December 2025 to December 2026. These will be replaced by lamps that are of a lower toxicity and increased energy efficiency."
